As previously discussed, please find attached the full proposal that we have received from Lee. This document draws on the comments from the small group that reviewed the proposal (our version of peer review). Are you able to get back to us with consolidated inputs by Monday 2 October COB? We will need to get this proposal to the external reviewers after Lee has considered the additional inputs from DFAT. After the external review, Lee can finalise and then ACIAR can wrap up to be ready for the ROU.

About the project budget envelope, ACIAR's Executive approved an additional \$500k to our previous commitment of \$3.2m. This is also in consideration of DFAT's indication that it can increase its funding to \$2.3m. Given these, I can confirm that the budget envelope for FIS/2023/133 looks like this:

- ACIAR contribution: \$ 3.7 million
- DFAT contribution: \$ 2.3 million
- Total funding available: \$ 6 million

Please note that ACIAR has a management fee that is being taken into account in the budget. Also, ACIAR CBR is aware that the DFAT contribution will be paid out in full this FY2023/24, preferably by December 2023. We can work towards this as soon as we get the proposal finalised and the ROU confirmed.

Hello Julia/Ann,

Many thanks for the budget template.

Have now completed and am pleased to submit along with the draft Phase 1 document. I have included the three year budget and, assuming smooth passage through subsequent IHR's from here, we hope the main project can transition smoothly from the SRA and commence in August 2019. As discussed, considering this project has been scoped for some time, and the majority of funds are coming from DFAT, the budget looks more like a Phase 2 than Phase 1. Hope this is OK.

Ann: Based on the November IHR experience I substantially revised this Phase 1. It seems that IHR indeed wanted more clarity/detail on methods, detailed workplans, analyses etc, so these are included in the attached (subsequently, it is closer to a Phase 2 than a Phase 1). I have stepped through the planned work in a methodical sense, showing linkages among activities and placed it into a broader regional strategic sense. I hope this is all OK and makes sense and is consistent with our original intent (SRA followed by main project).
