ACIAR is a small agency with a domestic and international focus. It comprises three branches: Research, Partnerships and Corporate. The Corporate branch provides operational management and comprises five sections: Finance, Human Resources, Information and Communication Technology, Procurement, and Business Engagement and Assurance.

A career in ACIAR's Corporate branch offers a unique opportunity to contribute to meaningful international development in a collaborative and supportive environment. If you're passionate about making a difference, want to be part of a branch that drives positive change, interested in pushing technical and policy boundaries, and value working within a talented and respected team, we encourage you to apply.

The Business Systems Section is responsible for the management and delivery of effective ICT services and technology environments in ACIAR. This includes contract management (our systems are primarily cloud based), support of internet and intranet services, records management, enterprise hardware and software, communications, stakeholder relationships and IT security.

We are seeking a high performing and motivated individual to join our team as our Director of ICT.

DUTIES INCLUDE:

Under general direction of the General Manager Corporate, the Director is responsible for:

- 1. Overseeing an effective cloud-based business system platform, including developing and implementing an ICT strategy and associated policies and practices to support business system users. This will include management of intranet and internet services, record keeping, and technical support.
- 2. Anticipating and responding to strategic and operational business system requirements to ensure effective implementation of technology solutions to enable ACIAR to deliver on its mandate.
- 3. Providing strategic technical advice to senior management on business system requirements, including IT security, with a focus on Cyber Security risks.
- 4. Managing the alignment of business systems to capture information and promote a culture of knowledge sharing across ACIAR. In collaboration with the business, develop and implement ACIAR's Data Strategy, ensuring alignment with organisational goals and objectives, and promoting data-driven decision-making across the agency.
- 5. Overseeing ICT projects, including new COTS-based or developed solutions, including project management, reporting and risks.
- 6. Managing the sections budget and ICT consultancy contracts.
- 7. Overseeing a small team responsible for app development and level 1 and 2 helpdesk support services, including documentation and training. Ensuring high performance through ongoing people management, on the role training, active monitoring and support.
- 8. Leading cultural change within the organisation and promoting a customer-focused culture within the business systems Section.

What you'll need to excel in this challenging role (selection criteria)

Our successful Director of ICT will possess:

- 1. Demonstrated ability to think strategically and develop and promote business systems and technologies (including cloud-based SharePoint platforms) that meet stakeholder needs, including online information systems, databases and electronic record management systems, and to assess their potential to meet ACIAR's long-term business needs.
- 2. Demonstrated awareness of Australian government requirements for information security (PSPF) including cyber security, cloud-based systems, knowledge and information management, consistent with Web Accessibility guidelines (WCAG2) and Collaboration (Gov2.0).

- 3. Excellent written and oral communication skills, including the ability to develop strategic and policy documentation and to communicate effectively with people at all levels, including individuals from diverse cultures.
- 4. Well-developed interpersonal skills with demonstrated ability to manage highly complex and sensitive customer relationships, including managing customer expectations.
- 5. Proven ability to lead and manage an ICT program and/or projects, whilst managing a small team supporting organisational change.
- 6. Demonstrated experience (preferably within the Public Sector) in ICT governance and procurement, including contract and budget management, liaising and negotiating with product vendors.
- 7. A degree or diploma in information technology or related discipline, or evidence of appropriate knowledge and experience to undertake the work in an information communications and technology environment.
